

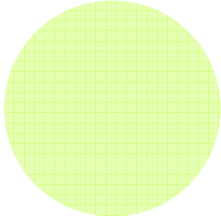

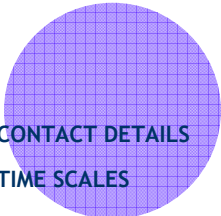

	Wills / Living Wills	4 - 6 weeks
PROBATE	Estates	6 - 12 months
	Grant of Probate / Letters of Administration only	3 months
	Lasting Power of Attorney / Court of Protection	4 months
LITIGATION	Matrimonial / Family	6 months
	Employment	3 months
	Personal Injury	4 months
